- (A) Meeting of the General Body comprising of all the enrolled members of the trust shall be held once in a year in the month of April and Special General Meeting shall also be held as and when required. The General Body will elect new managing body in after every Five Years.

If he/she refused to take notice personally, then it should be sent through R.P.A.D. The President elected by the Board of Trustees shall be the President of the Trust and he/she will take decision on the important matter in consultation with the other trustees. He/she will direct the Secretary to issue Notices of the Meetings. All the trust property will be under his/her supervision. He/she will deal with all legal affairs and represent the trust in Courts. He/she shall direct the Treasurer to provide the funds for the expenditure of the trust.

(2) Vice President :- In the absence of the President, the Vice President will be responsible for carrying out all the duties of the President except taking decision on the policy matters.

(3) Secretary :- The Secretary shall be responsible for all the office work (Registers, Receipts Books, Vouchers file etc.) He/she will keep all the documents. He/she will sign receipts etc.
